4.1 GREVILLEA STREET STORMWATER WORKS PROPOSAL

RECOMMENDATION

"That Council resolve to:

- a) Approve a new FY 2023/24 capital expenditure project for additional stormwater works at Grevillea Street and appoint State-Wide Earthworks Pty Ltd as the contractor without the standard request for quotation process through an exemption to the Code of Tenders and Contracts pursuant to Clause 10.9; and
- b) Authorise the General Manager to execute the necessary agreement."

Background

As part of the design process for capital renewal project C-23-T-006 Primrose Sands Road and Grevillea Street Reconstruction, it was identified that the stormwater network in this area is not sufficient. This conclusion was further supported by the Sorell stormwater pipe capacity analysis completed by Entura in 2019 which indicates that the current system cannot cope with a 63% annual exceedance probability rainfall event (or 1 year expected interval).



Upgrading this stormwater line is complex and costly due to a significant portion of the existing line going through 573 Primrose Sands Road within a narrow drainage easement. When this system cannot cope with stormwater, there is a significant risk of property damage due to inundation at 575 Primrose Sands Road.

As part of the current roadworks a new drainage line was installed which bypasses the existing undersized line through private property. This has reduced the stormwater load on the line through private property and hence, the risk of property inundation due to inadequate stormwater infrastructure. This new line reconnects to the existing line downstream of the property and discharges out of the existing outfall. The new line is a DN600 which connects to the existing DN375 with a grated pit to allow for overflow in the event of a heavy rainfall.

It was identified that it would be advantageous to upgrade 63 metres of the existing stormwater line downstream of the new connection to prevent overflow, reducing costal erosion and maintenance. The new line would ideally be a DN750 to ensure adequate capacity to accommodate the DN600 and DN375 lines which currently flow into it.

The existing outfall has been identified as not suitable for CERMP consideration due to good bank stability and minimal erosion, meaning it is in a good location. This outfall is large enough to accommodate a DN750 pipe without being replaced which should allow construction to be completed without disturbing the embankment downstream of the outfall.

This was not included in the original scope of the C-23-T-006 project for the following reasons:

- The stormwater line and outfall are located on Crown Land for which an application for consent to complete the works was required this has recently been obtained with Crown providing no objection to the proposal.
- It was not clear exactly where or how deep the existing stormwater line was and if it would be feasible to upgrade it was outside the scope of the design survey.
- The project was for the reconstruction of Primrose Sands Road and Grevillea Street, there was no stormwater component outside of what was essential for the facilitation of the road works.



Proposal

State-Wide Earthworks (SWE) commenced construction of the Primrose Sands Road and Grevillea Street roadworks in March 2024. These works are well underway and are expected to be complete in around 3 weeks.

SWE have provided a price to upgrade the 63 metres of existing DN375 concrete pipe to DN750. This proposal includes:

- Excavation and disposal of the existing pipe;
- Installation of new DN750 pipe; and
- Rehabilitation with a minimum of 4 native coastal plants per square metre.

The existing outfall is an insitu concrete outfall which is large enough to accommodate the new stormwater pipe and does not require replacement.

As SWE are currently on-site doing roadworks, they have the necessary plant and facilities to complete the works on hand without the need for additional mobilisation. Their quote excludes these typical costs.



The price provided for the works as described above is \$89,935 which equates to approximately \$1430 per metre including rehabilitation. There is an alternative solution which uses DN600 pipe instead of DN750 and is priced at \$76,075. This solution is not recommended as the pipe will still be undersized in a larger rain event. It is also worth noting that the price includes almost \$30,000 (or 33% of the total cost) for rehabilitation works.

If approved, these additional stormwater works can be completed alongside the roadworks with an estimated completion date of 31 May 2024.

It is proposed that a new 2023/24 capital job is created for the Grevillea Street Stormwater Upgrade with SWE appointed as the contractor.

- Reduce coastal erosion by conveying stormwater to an existing functioning discharge point.

Community Implications

- Reduced property inundation for 573 Primrose Sands Road.
- Reduced erosion down Council's beach access walkway.
- PM and contractor to liaise with affected community during works.



• Disturbed areas will be rehabilitated with native costal vegetation in consultation with Council's NRM Facilitator.

Recommendation

Clause 10.9 Exemptions of Sorell Council's Code of Tenders and Contracts states:

SWE have provided a quotation which excludes mobilisation and site setup with construction rates consistent with their recent tender for C-23-T-006 Primrose Sands Road and Grevillea Street Reconstruction. Due to the nature of the works and size of the required excavator, this component is likely to be more than 20% of the total price. Additionally, to prevent potential coastal erosion over the winter months, it would be advantageous to complete the works as soon as possible.

Based on the above and to achieve the best value for money, it is recommended that State-Wide Earthworks Pty Ltd are appointed the contractor for the proposed stormwater works without the standard tender process though an exemption to the Code of Tenders and Contracts under Clause 10.9.

 - (a) to gain, directly or indirectly, an advantage or to avoid, directly or indirectly, a disadvantage for oneself, a member of one's family or a close associate; or
 - (b) to cause any loss or damage to any council, controlling authority, single authority, joint authority or person.
