Sharon Fotheringham of Forcett questioned if there were any restrictions in place with the Penna Dog Beach?

The Manager Health and Compliance advised that to his knowledge this beach is classified as a year-round dog exercise area so no restrictions are in place.

Cathy Minnucci of Primrose Sands questioned regarding the new footpath at Tamarix Road, in particular the "dog legs" that have been created at the Nerine Street and in the vicinity of the Carlton Bluff Road intersections and whether these paths are now considered complete?

The General Manager advised that the Nerine Street junction works as constructed are complete with no further modifications proposed.

The General Manager further advised regarding the second section of the footpath that constraints with title boundaries and drainage have impacted construction but that he would need to confirm with staff in the first instance.

Cathy further questioned if representatives from Sorell Council will be attending the senate hearing into aircraft flight paths?

The General Manager advised that he would be attending Wednesday at 9.30am.

Dierdre Biggar of Dodges Ferry questioned regarding lack of street lighting on the intersection of Arthur Highway and Old Forcett Road and that there needs to be lighting placed on the Old Forcett Road side of the intersection.

The Mayor advised the General Manager would raise this with the Department of State Growth.

Dierdre further questioned regarding a footbridge that is being removed in the Lewisham area that she had read on social media?

The General Manager advised that this may be associated with Parks and Wildlife doing foreshore works in the area. They are constructing two formal pedestrian accesses down to the beach from the foreshore to enable



controlled access points and removing a number of privately constructed structures.

Deidre questioned regarding steps to the beach in the vicinity of First Avenue in Dodges Ferry that have been removed, do we know why?

The General Manager advised that he is unsure as to what has happened to the stairs but does not expect Council has removed them as they are not located on Council land.

Section 338A (1) of the Local Government Act 1993 states that a Councillor must not disclose information:

(a) seen or heard by the Councillor at a meeting or part of a meeting of a council or council committee that is closed to the public that is not authorised by the council or council committee to be disclosed; or (b) given to the Councillor by the mayor, deputy mayor, chairperson of a meeting of the council or council committee or the general manager on the condition that it be kept confidential.

Section 338A (3) states that a member must not disclose information acquired as such a member on the condition that it be kept confidential.

Additionally, Section 339 of the Local Government Act 1993 states that:

- (1) A councillor or a member must not make improper use of any information acquired as a councillor or member.
- (3) Improper use of information includes using the information
 - (a) to gain, directly or indirectly, an advantage or to avoid, directly or indirectly, a disadvantage for oneself, a member of one's family or a close associate; or
 - (b) to cause any loss or damage to any council, controlling authority, single authority, joint authority or person.
